- 1. SLOW-NO-WAKE SPEED REQUIRED FROM 8:30PM (OR SUNSET IF EARLIER) AND 6:00AM THE FOLLOWING MORNING.
- 2. SLOW-NO-WAKE SPEED REQUIRED AT ALL TIMES IN FOXTAIL BAY (EAST END OF LAKE).
- 3. SLOW-NO-WAKE SPEED REQUIRED WITHIN 200 FEET OF SHORELINE FOR PERSONAL WATERCRAFT (PWCs).
- 4. SLOW-NO-WAKE SPEED REQUIRED FOR WATERCRAFT OTHER THAN PWCs WITHIN 100 FEET OF SHORELINE.
- 5. SLOW-NO-WAKE SPEED REQUIRED WITHIN 100 FEET OF ANY WATERCRAFT OR OBJECT LEGALLY IN OR ON THE WATER (BOATS, PWCs, WATER SKIERS AND OTHER TOWABLES, DOCKS, PIERS, RAFTS OR BUOYED RESTRICTED AREAS).
- 6. A MAXIMUM SPEED LIMIT OF 50MPH IS IN EFFECT EXCEPT WHEN THE ABOVE SLOW-NO-WAKE RULES APPLY.
- 7. SWIMMERS MUST BE ACCOMPANIED BY A COMPETENT PERSON IN A BOAT WITH APPROPRIATE PERSONAL FLOATATION DEVICES (PFDs) ON BOARD WHEN MORE THAN 200 FEET FROM THE SHORELINE.
- 8. NO SWIMMING MORE THAN 200 FEET FROM THE SHORELINE FROM SUNSET TO SUNRISE.
- 9. WATERCRAFT TOWING WATER SKIERS OR OTHER TOWABLES REQUIRE EITHER A COMPETENT OBSERVER ON BOARD IN ADDITION TO THE DRIVER OR THE WATERCRAFT MUST BE EQUIPPED WITH A WIDE-ANGLE REARVIEW MIRROR.
- 10. A PERSONAL WATERCRAFT TOWING WATER SKIERS OR OTHER TOWABLES MUST BE DESIGNED TO SEAT AT LEAST 3 PERSONS.
- 11. NO WATER SKIING OR PULLING OF OTHER TOWABLES IS PERMITTED BEFORE 10:00AM OR AFTER 6:00PM ON SATURDAYS, SUNDAYS OR HOLIDAYS.
- 12. WATERCRAFT PULLING WATER SKIERS OR OTHER TOWABLES MUST STAY AT LEAST 100 FEET FROM ANY OTHER WATERCRAFT AND THEIR WATER SKIERS OR OTHER TOWABLES.
- 13. A DIVER DOWN FLAG ON A BOAT OR BUOY REQUIRES ALL WATERCRAFT AND THEIR WATER SKIERS OR OTHER TOWABLES TO STAY 100 FEET CLEAR OF THE AREA.
- 14. NO PERSON SHALL SWIM OR FLOAT MORE THAN 200 FEET FROM THE SHORELINE IN A TUBE OR OTHER FLOATATION DEVICE UNLESS ACCOMPANIED BY A COMPETENT PERSON IN A WATERCRAFT THAT HAS READILY AVAILABLE THE PROPER PFDs FOR ALL PRESENT.
- 15. ALL FEDERAL, STATE AND OTHER LOCAL LAWS APPLY. ANY TERM OR SUBSTANTIALLY SIMILAR TERM USED IN THESE REGULATIONS AND DEFINED IN STATE LAW HAS THE SAME MEANING AS SET FORTH IN THAT DEFINITION.
